Re-searched the Will of Peter Bruce in Halifax - Book 1, pg 69.

In the original Will, he lists the heirs in the following order: Wife Mary; Peter Bruce, Ann Fountain, Elizabeth Coats, Jean Bruce, Sarah Braswell, Alice Huett. March 1762. Exrs: Peter Bruce, ~~John Baitis~~ and wife, Mary Bruce. Trustees: Peter Bruce, John Fountain. In his Will he also listed as Exrs: ~~John Baitis~~ John Baitis and Robert Fountain. He does state "five" children in his Will and then lists six. The way I originally found this abstract was a listing of Peter Bruce and then Jean Bruce. I kept in mind that Jean might be Peter's wife, as they were listed together and he stated "five" children. Now, I'm beginning to wonder if "Jean" was French for John. You recall that the Will of George Bruce was translated as "George" and "Jacob" in the Court Records, and he signed his name "Jorg". We keep several things in mind. 1. Even if he could write, he was probably very sick. In fact in his Will he stated that he was sick and weak. 2. Then, they usually called in the nearest person who could write. I'm sure many of them had accents, and if they were sick they might not say things clearly. 3. The clerks did not use a uniform spelling. On the way home this afternoon, it occurred to me that Jean may be George. I found Peter with George so much that I felt that George must be the son of Peter, Jr. However, the dates of his grants etc. indicates that his age would really fit in better with Peter, Sr. This is probably the line to follow--try to find the different children of Peter, Sr. All the other girls were married. Peter and Jean are the only ones with the name of Bruce. *we found Jean to all children except "Jean"*

I also checked 1790 and 1800 Census as I didn't have anything on these; however, you probably already have these. In 1800 there was a George Bruce in Edgewcombe and the only Peter Bruce was in Iredell Co. I believe I ran across the information that he was a Minister. Most of the time early settlers owned land in several areas--all the way from the East Coast to the Mountains.

In 1811 and 1812, Thomas Bruce was a witness to two Deeds. No others mentioned in Abstract of Deeds for Pitt County.

We have very little re: the War of 1812. I'm sure that some misc. printed record would give the officers, but there is no definite information about this. In the following listing, a place was left for the officers' names but it was left blank for 1st Regiment, Edgecombe.

I have been told that the Nat'l Archives is planning to send us the records of N. C. for the War of 1812. At present, you might be able to get some information from them. *One of the ~~major~~ battles took place on the N.C. coast. I believe it was as late as 1815.*
