The entire Robert Dixon family has now been established, at least the male lines, with the location of Thomas Dixon in Elbert County, Georgia. The sons of Robert Dixon and Judith Burton were:

Most of this information is from the 1850 U S census of Thomas Co. Ga, but some is from the 1860 U S census of Elbert Co. Ga., as well as marriage records, etc. The picture emerging is that William Dixon must have returned to Elbert Co. after having moved earlier to Thomas Co. with Daniel Dixon and German Burton. The reason for the move is not apparent, and it appears that the older children_William, John, and Martha_and the younger Daniel, did not make the move. There is substantial evidence to support the conclusion that William returned to Elbert Co. First, the area to which he returned, Anthony Shoals (sometimes known as Petersburg) is the location in which he originally lived. It is also known as the 192nd Militia district which includes Coody"s Creek and the home of Robert Dixon. Secondly. the marriages of Elizabeth, Caroline, and Samuel W. Dixon all fit in the proper time sequences (dates and ages fit). Thirdly, the families of William, Samuel, and Thomas are all proximal to each other, and finally, the existence of a present day descendent, Roscoe Dixon, in the same general area of Elbert Co. Actually, Roscoe is dead, but his widow states that Roscoe's grandfather was Sam Dixon, and his grandmother was Mary Saxon Dixon.

Even though Robert Dixon had at least two daughters, according to census records, they remain to be identified. And although there are many questions to be answered, e.g.when did Thomas die, and where is he buried, when did Martha Dixon die, etc, we now have a good picture of the entire Robert Dixon-Judith Burton family. The major work remaining seems to be the question of Robert's grandparents (William and John's father). Please note that Thomas Dixon corroborates Blackman Dixon's statement that his mother and father were born in Virginia via the 1880 U S census of Elbert Co. Perhaps we can locate the Dixon's in Virginia and then in England.

* This is probably Mary J. Dixon who married Lafayette Roberson in Elbert Co. Also there is the possibility that R (A) is not Ann in that 1860 census, but Rebecca, who would be his (William's) new wife and mother of M. and M. J.. Notice

the census record family of Lafayette Roberson, that shows a Rebecca Dixon as mother-in-law. Thus, the catalyst sending William back to Elbert Co. may have been the death of Ann Wilson Dixon.
