## Tast Will and Testament

I, (Mrs.) Maude T. Shadman, a resident of St. Simon's
Island, Glynn County, Georgia, being of sound and disposing mind
and memory, do make and publish this as my LAST WILL AND TESTAMENT,
hereby revoking all other wills and codicils by me heretofore
made.

ITEM One. I desire and direct that all my just debts owing at my death be as promptly paid as may be done without embarrassment to my estate.

TTEM Two. I desire and direct that my body be buried beside the body of my beloved husband, James P. Shadman, Jr., in the cemetery of Christ Church, at Frederica, on St. Simon's Island in Glynn County, Georgia, in a decent and Chistianlike manner, suitable to my circumstances in life.

ITEM Three. I give, devise and bequeath unto my niece, Estelle McCaskill Egbert, as Trustee, for the use of my grandnephews, Edward McCaskill Egbert, Thomas Baker Egbert and Howard Leary Egbert, the children of my said niece, all real property, including my home place on St. Simon's Island, Glynn County, Georgia, of which I shall die seised, wheresoever located, whether now owned or herafter acquired. Said trustee is hereby authorized and directed to hold, manage and control all of such property and to receive and collect the rents, issues and profits that may accrue therefrom, and to pay all proper expenses incurred by her in connection with the trust estate, and in connection with her duties hereunder. Said trustee is also authorized to sell any, or all, of said trust estate, at public or private sale, or to exchange the same, at such prices and places as she may deem best, without previously obtaining the order of any Court authorizing her so to do; may invest and re-invest the proceeds of any sale, or any funds derived from said trust estate, in any other property, real

or personal, that she may deem best, regardless of whether or not the subject of such investment be of the character permitted by lawcto trustees; may borrow money or renew any loans made by me on said estate and give security for repayment thereof by mortgage, deed of trust, loan deed, or otherwise; may lease any of said property for any time regardless of the duration of the trust hereby created; all of which she may do without the order of any Court, with or without advertisement, without the necessity of giving bond or having any appraisals made or filing any returns to any Court. Said trust estate shall be used for the benefit of the three beneficiaries hereinbefore named, share and share alike, in the sole discretion of my said trustee, and the whole of said trust estate shall be delivered to the beneficiaries thereof when the youngest of said beneficiaries shall have attained the age of twenty-one years, share and share alike, whether said division shall be in kind (if the said trust property shall not have previously been sold or exchanged) or in other forms of assets derived from said trust property. Any purchaser of said property from said trustee shall not be required to look to the application of the proceeds of any such sale but shall take title thereto in the manner prescribed by the instrument executed by the said trustee.

ITEM Four. I give, devise and bequeath unto my beloved sister, Edna Taylor McCaskill, and my beloved niece, Estelle McCaskill Egbert, share and share alike, all of my personal property, owned at my death, except the amount of money hereinafter designated to be set aside as a cemetery trust.

ITEM Five. I specifically bequeath unto my executor, hereinafter named, the sum of five hundred dollars (\$500.00), in trust nevertheless, to hold the same in perpetuity and use the income therefrom for repairing, improving, maintaining and beautifying the cemetery lots composing the Shadman Plot at Frederica, St. Simon's Island, Georgia, whereon my beloved husband,

James P. Shadman, Sr., is now buried and whereon I request that I also be buried. Said trustee may, from time to time, encroach upon the corpus of said trust fund, as he may, in his uncontrolled discretion, deem best and proper.

ITEM Six. Should the beneficiary of any trust or devise or bequest herein made predecease me, I direct that the subject of such trust, devise or bequest, be divided and delivered to such beneficiaries' legal heirs per stirpes and not per capita, in the manner, and at such time, or times, as hereinbefore specified.

ITEM Seven. I hereby constitute and appoint my friend,

I. M. Aiken, of Brunswick, Glynn County, Georgia, as the sole
executor of this my will. I hereby relieve my said executor from
giving bond or making any returns to the Court of Ordinary, or any
other Court, and I expressly confer upon him the power and authority
to sell any part of my estate at public or private sale, with or
without notice, at such prices and places as he may deem best, and
without any order of court, making good and sufficient conveyances
to the purchaser, or purchasers, and holding and/or disposing of
the proceeds in any manner he may deem best. I further expressly
confer upon him the authority and power to borrow money for the use
of my said estate, in any instance where he may think it necessary
and deem best, and to secure the same by lien, mortgage, security
deed, trust deed, or other form of security. I relieve my said

Executor from making any returns to, and securing or filing any inventories or appraisals with, any court while acting in any capacity hereunder. My executor is at this time President of the American National Bank of Brunswick, Georgia, and in the event of the death, resignation or refusal to act of my said executor (or of the death of any successor executor hereunder) prior to the time he may qualify or my estate has been wound up, I nominate, constitute and appoint such person as may be selected by the Boad of Directors of the American National Bank as successor executor of this my last will and testament, conferring upon him the same rights, powers and
